Broadband

Terry Brown and Mark Dye attended a meeting given by the county about broadband in Otsego County. The county has received a grant and hired a North Dakota company to do a feasibility study about what is needed to bring broadband to a greater number of people in the county (more towers, etc.). Most people in attendance were very frustrated by the internet connections available in the rural areas.
