Planning Board

The planning board is currently working on a lot line adjustment/lot split on County Highway 7 and a home occupation business for baked goods on Mill Creek Road.

Boiler Inspection

The inspection has been completed and mailed back to the state on August 1, 2023. The state boiler inspector showed up to verify the inspection and we now are good until July 2025.

Dog Control Officer

There have been no applications to date. Ellen has posted the position on the NYS DCO Facebook page and has taken flyers to area veterinarians. After discussion and price comparisons, the town approved advertising the job in the Pennysaver and All-Otsego and its affiliate newspapers.

ZBA Training

The Zoning Board is in need of updated training. Beth has agreed to look at her schedule for possible dates in September – with the time period of 4 pm to 5:30 pm. She will get back to Stuart Anderson, Zoning Board Chairman, with her suggestions.
