Town Clerk Report

Terri Horan presented the Town Clerk report for January.

Tax collection is completed for the month of January. The town warrant has been paid, \$250,000 has been sent to the county and 70.85% of the total warrant has been collected.

County Representative

Mr. Brockway reported the County has a new septic tank replacement program, in cooperation with the NYS DEC. For Otego homeowners, any properties that need septic tanks replaced and are within 250 feet of the main branch of the Susquehanna River may have up 50% of the costs covered. Residents should apply to the county.

Mr. Wilber said it has been a slow season so far. He will be issuing a permit for a marijuana growing greenhouse and barn operation on county highway 48 under agriculture in the near future.

Highway Report

Planning Board

The planning board did not have a meeting last month. The zoning commission is still proceeding with zoning documents. They should be ready to review shortly.

New rugs/tile flooring

The flooring will be paid with ARPA funding but Kathy will investigate if a portion of JCAP could help cover the costs. More information on to the timing of the replacement will be forthcoming and may be delayed by the use of the courtroom by Unadilla's Town Hall and Court.

Supervisor Hurlburt reached out to the Town of Unadilla in the aftermath of an accident which damaged the Town of Unadilla courtroom and town hall. Unadilla will get back to us if they need to take up the offer.
