#### Highway

Mr. Hurlburt noted that he received a call about water running across the road on Mill Creek Road. He investigated and found that the beaver dam had broken, but the water dispersed quickly and was not a problem.

The highway committee met to discuss which roads to pave and the purchase of a new backhoe at a cost of \$123,072.67 from CHIPS money. Based upon the recommendation of the Highway Committee, Barbara Stanton made a motion to purchase the backhoe, seconded by Jimmy Hamm. All in Favor 5, 0 Nays.

Terry Brown also made a motion to surplus the existing town backhoe and place it in Auctions International, seconded by Royce Livingston. Motion: 5 Ayes, 0 Nays.

#### Planning Board

Lois Chernin reported that the planning board has a minor sub-division hearing for this month and that they have had hearings almost every month in 2023. Since the cost of advertising these hearings has gone up, they may have to look at adjusting some of the planning board fees to cover this cost.

#### **Boiler Inspection**

The town supervisor reported that the insurance inspection of the boiler is being taken care of by our insurance representative - who has already tried on several occasions to get one scheduled. She is still working on it.

#### **Air-Conditioning**

D & D Refrigeration out of Morris has contacted the Town Supervisor saying the equipment is in to update the air conditioning in the back offices and move the thermostat, but he has not been able to get a time/date for installation from them yet.

#### Dog Control Officer

The position of Otego Dog Control Officer has not received any applications to date. It has been posted on the town website and town bulletin boards. It will go on the electronic sign and the town clerk will look for other budget friendly means to advertise the position before it is run in the Daily Star.
