# Town Clerk Report

Mrs. Horan gave the Town Clerk report for April. Tax collection ended at 83.20 % collected for a total of \$1,673,469.74. Tax season is now complete; she will settle with the county on Friday, May 23, 2025.

# County Representative

In light of the recent Otego Clean Up Day, many residents are interested in knowing when the Otsego County Hazardous Waste Days are going to be this summer. Mr. Brockway believed in August or September but will check on it.

#### Code Officer

Mr. Wilber reported that building permit applications for new construction and renovations are up, with two new housing permits being issued.

## Highway Report

JR met with Soil and Water to discuss how to shore up the banks where the Little League field is located. He will proceed with the permitting process but was told there were currently no funds available to help defray costs. Dan Wilber suggested reaching out to our legislators to see if they can help.

The highway department annual expenditure agreement was presented to the board. Royce Livingston made a motion, seconded by Barbara Stanton, to approve the agreement. Motion: 5 Ayes, 0 Nays. Board Members signed the agreement as presented.

The Secor Road bridge repair work has been completed and is being cleaned up. It should be ready for re-opening next week.

The highway superintendent also reported that there have been several areas of trash and garbage debris dumped around Flax Island. While the highway department was cleaning up one pile, they ran into forest rangers investigating other areas of illegally disposed of trash.

#### Planning Board

The planning board held a public hearing in April and also approved a home occupation business. In addition, Planning Board Secretary Colleen Bushnell submitted her official resignation letter. Barbara Stanton made a motion to accept the resignation, seconded by Jimmy Hamm. Motion: 5 Ayes, 0 Nays

Lois will prepare a job description of the planning board secretary, to be posted by the town clerk. The town clerk will also send a letter to Colleen Bushnell thanking her for her many years of service to the residents of the town as well as to the town and planning boards.

### New Business

Town of Otego .gov website. Per new NYS requirements, all villages, towns, and cities having a population over 1,500 persons must now transition to a more secure .gov website. The first step in the process is to obtain authorization from the town board or senior officials. Terry Brown made a motion, seconded by Royce Livingston, for the Town of Otego to begin the changeover to a .gov website. Motion: 5 Ayes, 0 Nays

The town clerk will get with Steve Lawton to choose a name and start work on the transition.

#### Warrant #5
