### Reports:

Jimmy Hamm reports for the Town Board:

- Rick Brockway notified the Town of Otego there will be Hazardous Waste Days August 25th, 8:00-11:00 am, in Unadilla and August 26th, 8:00-11:00 am in Cooperstown.
- The Town Board is still seeking a replacement for the position of Dog Warden.
- The boiler and the air conditioner in the Town Hall have been repaired.

#### **New Business**

- Hector Cotto is present regarding an application for a Boundary Line Adjustment at 1271 County Highway 7. There are two small parcels he would like joined with a larger parcel.
- The first parcel is 5.9 acres with tax # 285.00-1-24.02. The second parcel is 6.13 acres with tax # 285.00-1-26.00. They would be joined to the parcel of 131.45 acres with tax # 285.00-1-24.01 for a total acreage to become 143.45 acres.
